A RESOLUTION AWARDED A CONTRACT TO PERNA FINNIGAN, INC., VINELAND, NJ, FOR THE 2019 CITY-WIDE DRAINAGE IMPROVEMENTS PHASE 1, IN THE AMOUNT OF \$274,457.40.

WHEREAS, the City of Vineland has heretofore advertised for bids for the 2019 City-wide Drainage Improvements, Phase 1, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on May 29, 2019, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of July 18, 2019 submitted a written report and tabulation of the bids received and has recommended that a contract for the 2019 City-wide Drainage Improvements, Phase 1, be awarded to Perna Finnigan, Inc., Vineland, NJ, in the amount of \$274,457.40, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the 2019 City-wide Drainage Improvements Phase 1, be and the same is awarded to Perna Finnigan, Inc., Vineland, NJ, on their bid in the amount of \$274,457.40, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.


