RESOLUTION SUPPORTING THE NEW JERSEY DEPARTMENT OF TRANSPORTATION PROHIBITION OF LEFT TURNS INTO AND OUT OF THE DRIVE WAY OF BLOCK 6101 LOT 25 OFF OF AND ONTO ROUTE 47 IN ACCORDANCE WITH N.J.S.A. 39:4-8.4(c)

WHEREAS, the Planning Board of the City of Vineland recently approved the site plan for the construction of a retail alcohol distribution and consumption facility located along Route 47 (Delsea drive) and CR552 (Sherman Avenue) in the City of Vineland also known as Block 6101, Lot 25 on the City of Vineland Tax Map; and

WHEREAS, Route 47 is a State Highway and CR552 is a County Highway with the ultimate control of the intersection of Route 47 and CR552 being with the State of New Jersey; and

WHEREAS, on April 27, 2018 Kenneth Spiegle, Project Engineer, New Jersey Department of Transportation Office of Major Access Permits allowed an access permit onto Route 47 but required the left turns to be prohibited into and out of the drive way along Route 47 by a Traffic Regulation Order for State Highways pursuant to N.J.S.A. 39:4-8.3; and

WHEREAS, the staff of the Bureau of Traffic Engineering (BTE) completed an investigation which findings support the request of the Project Engineer and have recommended that left turns prohibition regulation be implemented at said intersection; and

WHEREAS, the City Council recommends that no person shall make a left turn at any location on Block 6101, Lot 25 exiting said property to travel southbound on Route 47 or a left turn entering said property traveling northbound on Route 47 which would otherwise require left hand turns traversing several lanes of Route 47.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Vineland that the City of Vineland concurs with the staff report of BTE and the Project Engineer and any approved traffic regulation in conflict with or inconsistent with the provisions of this Resolution and the reports referenced herein above be rescinded upon approval of the Traffic Regulation Order for State Highways pursuant to N.J.S.A 39:4-8.3

Dear Mr. Petrosky:

This is in reference to the recently opened Toast Wine and Spirits/Brass Tap Stores, located along Route NJ 47 (Delsea Drive) and Sherman Avenue (CR552) in the City of Vineland, County of Cumberland, (Block 6101, Lot 25) on the City of Vineland Tax Map). Based upon a request dated April 27, 2018 from Kenneth Spiegle Project Engineer, NJDOT Office of Major Access Permits, approval for the Access Permit requires that *Left Turns* be prohibited into and out of the driveway, along Route NJ 47 (Delsea Drive) by a *Traffic Regulation Order* for state highways pursuant to N.J.S.A. 39:4-8.3.

Staff of the Bureau of Traffic Engineering (BTE) has completed an investigation. Based upon this investigation our findings support the request, and have recommended that the *Left Turns Prohibition* regulations be implemented as indicated below.

An initial step in the TRO process is to receive a *Resolution* of support from the municipal governing body pursuant to N.J.S.A. 39:4-8-4(c). It is therefore, requested that a certified adopted *Resolution* of support containing the <u>raised</u> <u>seal</u> of the City of Vineland be submitted to this office, which reads substantially as follows:

Route NJ 47 (Delsea Drive)

Turn Prohibitions:

No person shall make a turn at any location listed and only in the manner described:

Intersection / Location

Route NJ 47 and the exit driveway of the Toast Wine and Spirits/Brass Tap Stores (Block 6101, Lot 25) (244 feet north of the northerly curb line of West Sherman Avenue) (CR552). Approximate milepost (43.75)

Turn Prohibited

Left Turn

Movement Prohibited

From the exit driveway of the Toast Wine and Spirits/Brass Tap Stores *eastbound* onto Route NJ 47 *northbound*.

Route NJ 47 and the entrance driveway of the Toast/Wine and Spirits/Brass Tap Stores (Block 6101, Lot 25) (244 feet north of the northerly curb line of West Sherman Avenue (CR552). Approximate milepost (43.75). Left Turn

From Route NJ 47 *northbound* into the entrance driveway of Toast Wine and Spirits/Brass Tap Stores *westbound*.

Repealer Clause:

The City of Vineland concurs that any approved traffic regulation in conflict with or inconsistent with the provisions of this *Resolution* be rescinded upon approval of the *Traffic Regulation Order*.

Once this office is in receipt of the certified adopted *Resolution* of support from the City of Vineland, a *Traffic Regulation Order* will be promulgated.
