

RESOLUTION NO. 2019-327

A RESOLUTION AUTHORIZING THE ISSUANCE OF AN AMENDATORY SUPPLEMENTAL CHANGE ORDER NO. 1, TO PURCHASE ORDER NO. 19-03892 ISSUED TO WINNER FORD, CHERRY HILL, NJ, IN THE AMOUNT OF \$2,400.00.

WHEREAS, the City Council of the City of Vineland, on May 14, 2019, adopted Resolution No. 2019-193, entitled “RESOLUTION AUTHORIZING A CONTRACT AWARD TO A STATE CONTRACT VENDOR, WINNER FORD, CHERRY HILL, NEW JERSEY, FOR THE PURCHASE OF TWO (2) FORD F450 4X4 DUMP TRUCKS FOR THE DEPARTMENT OF PUBLIC WORKS, IN AN AMOUNT NOT TO EXCEED \$136,974.00”; and

WHEREAS, N.J.A.C. 5:30-11.1, et seq., sets forth the requirements for the processing of change orders; and

WHEREAS, the Vehicle Maintenance Administrator has requested that an amendment be made to Purchase Order No. 19-03892 awarded to Winner Ford, Cherry Hill, NJ for the purchase of two (2) Ford F450 4x4 Dump Trucks, as authorized by Resolution No. 2019-193: said amendment is necessary due to the fact that there is a fuel tank issue with the 2019 Ford F450 model dump trucks and only 2020 models can now be ordered, at \$1,200 per truck; and

WHEREAS, the City of Vineland desires to comply with said requirements of N.J.A.C. 5:30-11.1, et seq., and to that end herewith files with the governing body a report stating the facts involved and indicating that the proposed change order may be allowed under these regulations; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the amendatory supplemental change order for which authorization is requested in the amount of \$1,200.00 per truck for a total change order amount of \$2,400.00; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said amendatory supplemental change order # 1 to purchase order #19-03892 issued to Winner Ford, Cherry Hill, NJ, in the total amount of \$2,400.00, be and the same is hereby ratified and approved.

We are requesting that an amendatory supplemental change order be issued to Purchase Order No. 19-03892 issued through the State of NJ Cooperative Purchasing Program to Winner Ford, Cherry Hill, NJ for the purchase of two (2) Ford F450 4x4 Dump Trucks. This contract was authorized by Resolution No. 2019-193, adopted by City Council on May 14, 2019.

The change order requested, in the total amount of \$2,400.00, will provide for additional funds needed to order the 2020 dump truck models. This change is necessary because there is a fuel tank issue with the 2019 Ford F450 model dump trucks and only 2020 models can now be ordered, at \$1,200 per truck.

This change represents an increase of approximately 1.7522% over the original contract amount of \$136,974.00.


