RESOLUTION AUTHORIZING THE TRANSFER OF A 2012 CHEVROLET IMPALA FROM THE COUNTY OF CUMBERLAND FOR ITS USE BY THE VINELAND FIRE DEPARTMENT.

WHEREAS, the County of Cumberland currently maintains a 2012 Silver 4 Door Chevrolet Impala which is no longer needed for public use; and

WHEREAS, N.J.S.A., 40A:11-36, entitled "Sale or Other Disposition of Personal Property," provides that any contracting unit by resolution of its governing body may authorize the sale of its personal property not needed for public use; and

WHEREAS, said statute further provides that the contracting unit need not advertise for bids when it makes any such sale to another contracting unit or any governmental unit in the United States; and

WHEREAS, the Director of Fire has indicated the need for the 2012 Silver 4 Door Chevrolet Impala for service in the City of Vineland Fire Department and is requesting authorization to purchase said vehicle at a purchase price of \$100.00; and

WHEREAS, the Cumberland County Board of Chosen Freeholders has adopted a Resolution authorizing the sale of the 2012 Silver 4 Door Chevrolet Impala, VIN: 2G1WD5E36C1195666; 96,838 miles, in "Where Is, As Is" condition, for the purchase price of \$100.00; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the acquisition of the 2012 Chevrolet Impala, in the amount of \$100.00;

NOW THEREFORE BE IT RESOLVED by the Council of the City of Vineland that the Mayor and Clerk are authorized to execute any and all documents necessary for the acquisition of the 2012 Silver 4 Door Chevrolet Impala, for the purchase price of \$100.00, in accordance with N.J.S.A. 40A:11-36.
