RESOLUTION AUTHORIZING A CONTRACT AWARD TO A STATE CONTRACT VENDOR, WINNER FORD, CHERRY HILL, NEW JERSEY, FOR THE PURCHASE OF THREE (3) 2020 FORD EXPLORERS, FOR THE MUNICIPAL ELECTRIC UTILITY – DISTRIBUTION DIVISION, IN AN AMOUNT NOT TO EXCEED \$96,192.00.

WHEREAS, it has been recommended that a contract be awarded to Winner Ford, Cherry Hill, New Jersey (A88728) for the purchase of three (3) 2020 Ford Explorers, for the Municipal Electric Utility – Distribution Division, in an amount not to exceed \$32,064.00 each, for a total cost of \$96,192.00, in accordance with the quote from Winner Ford, Cherry Hill, New Jersey, attached hereto and made a part hereof; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for said contract to be awarded; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts.
