A RESOLUTION AUTHORIZING THE EXECUTION OF SUB-GRANTEE AGREEMENTS FOR THE USE OF FISCAL YEAR 2019 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR PUBLIC SERVICES & FACILITIES.

WHEREAS, the City of Vineland has entered into a Grant Agreement with the U. S. Department of Housing and Urban Development for Fiscal Year 2019 Community Development Block Grant Program funding, and

WHEREAS, said contract with the U. S. Department of Housing and Urban Development provides for the subgranting by the City of Vineland of a portion of the F. Y. 2019 Community Development Block Grant funding to subrecipient non-profit organizations to be utilized for public services as set forth in the Final Statement of Community Development Objectives and Projected Use of Funds for Federal Fiscal Year 2019, filed with HUD by the City of Vineland; now, therefore,
