WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY HE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare a purchase order to procure Ninety-Three (93) Taser X7 Conductive Energy Devices (CED) for a price not to exceed a total of \$361,375.00 for a period of five (5) years, beginning January 1, 2020.
