A RESOLUTION AUTHORIZING A CONTRACT WITH SIGNAL CONTROL PRODUCTS, INC., BRANCHBURG, NJ FOR THE PURCHASE OF A TRAFFIC LIGHT CONTROL CABINET FOR THE INTERSECTION OF PARK AVENUE AND EAST AVENUE THROUGH THE CUMBERLAND COUNTY COOPERATIVE PURCHASING SYSTEM.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System pursuant to Resolution No. 96-534 adopted on August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Contract Purchasing System Identifier for #181-CCCCPS for providing and delivering various traffic signal equipment and sign materials; and

WHEREAS, the City of Vineland is in need of a traffic light control cabinet to replace one that was damaged due to an accident at the intersection of Park Avenue and East Avenue; and

WHEREAS, the City of Vineland desires to enter into the contract with Signal Control Products, Inc., Branchburg, NJ for the purchase of a traffic light control cabinet for the intersection of Park Avenue and East Avenue, in the amount of \$20,070.00, under the cooperative purchasing system contract awarded by the County of Cumberland; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the contract to be awarded herein.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

The Mayor and City Clerk are hereby authorized to execute an agreement with Signal Control Products, Inc., Branchburg, NJ for the purchase of a traffic light control cabinet for the intersection of Park Avenue and East Avenue, in the amount of \$20,070.00, based upon the cooperative purchasing system contract awarded by the County of Cumberland.
2. The Purchasing Agent is hereby authorized and directed to issue a contract for the purchase of a traffic light control cabinet for the intersection of Park Avenue and East Avenue.

WHEREAS, the maximum contract award amount is \$1,111,466.69; and
