A RESOLUTION AWARDING AN OPEN-END CONTRACT TO PRECISION FILTRATION PRODUCTS, PENNSBURG, PA FOR THE FURNISHING OF VMEU COMBUSTION TURBINE FILTERS.

WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing of VMEU Combustion Turbine Filters, for the contract period beginning March 12, 2020 through March 11, 2021, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on February 11, 2020, a bid was received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of March 3, 2020, submitted a written report and tabulation of the bid received and has recommended that an open-end contract for the furnishing of VMEU Combustion Turbine Filters, be awarded to Precision Filtration Products, Pennsburg, PA for Groups A through E only, as provided in the specifications:

## PROJECT SUMMARY

### OPEN ENDED SPECIFICATION FOR VMEU COMBUSTION TURBINE FILTERS

2020-21

This specification is for an open ended contract for various newly manufactured filter elements required for the Utility owned three (3) combustion turbine units located at the Howard M. Down , Clayville and West Sub. generating stations. Initial order quantities as specified will be ordered at the time of award and additional quantities will be ordered on an as needed basis in quantities equal to or greater than the minimum re-order quantities specified for each item.

There are about twenty five (25) types of filters required for the above stations. All of the required filters may or may not be available from a single source for the best price and delivery. The required filters have, therefore, been split into five (5) groups based on filter sources to facilitate awarding contracts to different vendors by filter group to suit the best interest of the Utility.
