WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing and delivery of 15KV URD Cable for the Vineland Municipal Electric Utility, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on February 11, 2020, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of March 3, 2020 submitted a written report and tabulation of the bids received and has recommended that a contract for the furnishing and delivery of 15KV URD Cable for the Vineland Municipal Electric Utility, be awarded to Rumsey Electric Company, Conshohocken, PA, in the amount of \$146,725.27, plus a contingency in the amount of \$7,336.26 to allow for manufacturer's standard length put-up tolerances of +/-10%, said bid being the lowest qualified bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the furnishing and delivery of 15KV URD Cable for the Vineland Municipal Electric Utility, be and the same is awarded to Rumsey Electric Company, Conshohocken, PA, in the amount of \$146,725.27, plus a contingency in the amount of \$7,336.26 to allow for manufacturer's standard length put-up tolerances of +/-10%, said bid being the lowest qualified bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contracts for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contracts to be awarded herein are available.


