A RESOLUTION AMENDING RESOLUTION NO. 2018-236, TO EXTEND THE PERIOD OF THE CONTRACT ISSUED TO SIMPLY CLEAN AIR & WATER INC., NEWINGTON, CT FOR THE FURNISHING, DELIVERY AND INSTALLATION OF MOBILE DEMINERALIZER SYSTEM.
