American Bituminous (89.6 miles x $4.00 = 358.40 \times 50$ round-trips =17,920.00 round-trip for County pick-up at W. Collingswood Heights Plant) plus materials cost and supply/deliver equals 173,920.00 total bid.

WHEREAS, no amount will be encumbered until such time as good or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$146,696.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends a contract be awarded to Richard E. Pierson Materials Corporation in accordance with the specifications and the bid of the contractor in the maximum amount of \$146,696.00 for the contract period September 1, 2020 through August 31, 2021. The County shall have the option to renew for one (1) additional one (1) year term.

- That, additionally, Richard E. Pierson Materials Corporation shall be declared the winning bidder for the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS.
- That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.
