City of Vineland employees will be evaluated within one hour of arrival.

Premier Orthopaedic Associate physicians have full active privileges at South Jersey Hospital System-Regional Medical Center Division located in Vineland, New Jersey. Our physicians will personally direct emergency care requiring hospital referral. Thus the City of Vineland will not "lose control" of any medical or workers compensation case. This allows the City of Vineland to contain medical costs conservatively.

At the discretion of the Premier Orthopaedic Associates on call surgeon, more serious injury of City of Vineland employees may be directed to the Emergency Department at South Jersey Hospital System Regional Medical Center, 1505 West Sherman Avenue, Vineland, New Jersey 08360 for required emergency treatment. Premier Orthopaedic Associates does not intend to establish (expressed or implied) a joint venture or partnership agreement/arrangement with the Emergency Department of South Jersey Hospital System – Regional Medical Center. Premier Orthopaedic Associates requests that the City of Vineland issue a letter, (in the event Premier Orthopaedic Associates is awarded this contract), to the Emergency Department of South Jersey Hospital System – Regional Medical Center identifying Premier Orthopaedic Associates as the only authorized treating physicians for City of Vineland employees.

City of Vineland employees discharged by the Emergency Department at SJHS RMC Division should be referred to our facility to be evaluated at the first available appointment the next business day.

Premier Orthopaedic Associates offers a medication program for employees to receive medication, i.e. antibiotics, anti-inflammatories, pain medication, at the time of their visit at a reduced cost. This allows the employer to begin medical regiment immediately.
