RESOLUTION EXERCISING OPTION TO RENEW THE
CONTRACT FOR SECURITY GUARD SERVICES.

WHEREAS, on December 23, 2019, City Council adopted Resolution No. 2019-556, awarding an open-end contract to Security Guard, Inc., t/a Tri-County Security, Vineland, NJ, for Security Guard Services, in the amount of \$35,200.00 for a period from January 1, 2020 to December 31, 2020, with option to renew for one additional year ending December 31, 2021; and

WHEREAS, the Purchasing Agent has advised that it is necessary to exercise the contract one year option renewal ending December 31, 2021, for an estimated amount of \$43,450.00 (\$18.75 per hour at City Hall and \$19.75 per hour at the Municipal Court), based on approximately 2,200 hours; and

WHEREAS, the City of Vineland and Security Guard, Inc. have agreed to extend the contract for a one additional year ending December 31, 2021 at the same terms and conditions of the original contract and the agreed upon hourly rates;

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized and directed to amend Resolution 2019-556 to exercise the option to renew for one additional year ending December 31, 2021, for an estimated amount of \$43,450.00 (\$18.75 per hour at City Hall and \$19.75 per hour at the Municipal Court), based on approximately 2,200 hours.

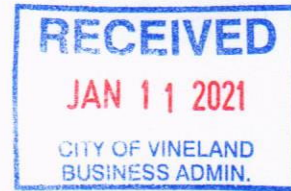




