RESOLUTION RATIFYING AND CONFIRMING THE APPOINTMENT OF TESTA HECK TESTA AND WHITE, P.A., VINELAND, NJ AS PART-TIME ALTERNATE MUNICIPAL COURT PUBLIC DEFENDER FOR THE MUNICIPAL COURT OF THE CITY OF VINELAND AND AUTHORIZING THE MAYOR AND CLERK TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT THEREFORE.

Fanucci appointed Testa Heck Testa and White, P.A., as Alternate Public Defender, part time, and the City Council of the City of Vineland finds he meets all of the requirements to serve in the capacity of Alternate Public Defender, part time.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Vineland as follows:

1. The appointment of Testa Heck Testa and White, P.A. as Alternate Public Defender part time, is hereby ratified and confirmed subject to any applicable pre-employment qualifications to commence upon taking the oath of office.

2. The salary for Testa Heck Testa and White, P.A., shall be in accordance with Ordinance in the amount of \$280.00 per diem.

3. The Mayor and Clerk are authorized to execute a Professional Services Agreement to commence February 1, 2021 and for a period of one year or until reappointment or a successor is appointed and qualified. Said Agreement shall be in the form and substance approved by the Solicitor for the City of Vineland.
