A RESOLUTION AWARDDING AN OPEN-END CONTRACT
TO AWP, INC., NORTH CANTON, OH FOR TRAFFIC
CONTROL SERVICES.

WHEREAS, the City of Vineland has heretofore advertised for bids for Traffic Control Services for the Vineland Municipal Electric Utility, for a period of one year commencing on March 11, 2021 ending March 10, 2022, with option to renew for one (1) additional year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on January 26, 2021, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of February 16, 2021, submitted a written report and tabulation of the bids received and has recommended that an open-end contract for Traffic Control Services for the Vineland Municipal Electric Utility, be awarded to AWP, Inc., North Canton, OH, in the amount not to exceed \$349,627.00, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for Traffic Control Services for the Vineland Municipal Electric Utility, for a period of one year commencing on March 11, 2021 ending March 10, 2022, with option to renew for one (1) additional year, be and the same is awarded to AWP, Inc., North Canton, OH, in the amount not to exceed \$349,627.00, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
