A RESOLUTION AUTHORIZING A CONTRACT WITH G.M. WHITE ELECTRICAL CONTRACTOR, INC., VINELAND, NJ FOR PROVIDING AS-REQUIRED ELETRICAL INSTALLATION AND REPAIR SERVICES THROUGH THE CUMBERLAND COUNTY COOPERATIVE PURCHASING SYSTEM, IDENTIFIER #181-CCCCPS; BID 18-27 RESUBMISSION.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System pursuant to Resolution No. 96-534 adopted on August 13, 1996; and

WHEREAS, on September 25, 2018 the County of Cumberland, as the Lead Agency, awarded on behalf of all participating contracting units in the Cooperative Contract Purchasing System Identifier #181-CCCCPS, a contract with G.M. White Electrical Contractor, Inc., Vineland, NJ for Providing As-Required Electrical Installation and Repair Services, for a one year period with option to renew said contract for two additional one year periods; and

WHEREAS, the County of Cumberland on August 25, 2020 exercised the second and final renewal option year through September 30, 2021; and

WHEREAS, the City of Vineland is in need of As-Required Electrical Installation and Repair Services; and

WHEREAS, the City of Vineland desires to enter into the contract with G.M. White Electrical Contractor, Inc., Vineland, NJ for providing As-Required Electrical Installation and Repair Services, under the cooperative purchasing system contract awarded by the County of Cumberland; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the contract to be awarded herein.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

1. The Mayor and City Clerk are hereby authorized to execute an agreement with G.M. White Electrical Contractor, Inc., Vineland, NJ for providing As-Required Electrical Installation and Repair Services, based upon the cooperative purchasing system contract awarded by the County of Cumberland Identifier #181-CCCCPS; Bid 18-27 Resubmission.
2. The Purchasing Agent is hereby authorized and directed to issue a contract for As-Required Electrical Installation and Repair Services through September 30, 2021.

**RESOLUTION EXERCISING SECOND AND FINAL RENEWAL
OPTION TO THE CONTRACT BID 18-27 RESUB PROVIDING AS-
REQUIRED ELECTRICAL INSTALLATION AND REPAIR SERVICES
FOR THE COUNTY OF CUMBERLAND AND THE CUMBERLAND
COUNTY COOPERATIVE CONTRACT PURCHASING SYSTEM
IDENTIFIER #181-CCCCPS (G.M. WHITE ELECTRICAL
CONTRACTOR, INC.) (\$250,000.00)**

WHEREAS, on September 25, 2018, this Board duly adopted Resolution 2018-529, Awarding Contract For Providing As-Required Electrical Installation And Repair Services for The County Of Cumberland And The Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; Bid 18-27 Resubmission; and

WHEREAS, the Director of Purchasing has advised that it is necessary to exercise the second and final option to renew the contract for an additional one (1) year through September 30, 2021; and

WHEREAS, the maximum contract award amount is \$250,000.00; and

WHEREAS, no amount will be encumbered until such time as good or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to

exceed the maximum contract award of \$250,000.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby authorizes an amendment to Resolution 2018-529 exercising the second and final renewal option to said contract in the maximum amount of \$250,000.00 for an additional one (1) year through September 30, 2021 with all other terms and conditions of the original contract to remain unchanged.

2. That said contract extension shall also apply to participating members of the Cumberland County Cooperative Contract Pricing System Identifier #181-CCCCPS.
