A RESOLUTION AUTHORIZING A CONTRACT AWARD TO A STATE CONTRACT VENDOR, R.F. DESIGN & INTEGRATION, INC. BENSALEM, PENNSYLVANIA FOR ACQUISITION AND INSTALLATION OF NON-EMERGENCY UHF RADIO SYSTEM INFRASTRUCTURE IN THE AMOUNT OF \$218,135.13.

WHEREAS, the City of Vineland pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:347.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the City of Vineland intends to enter into a contract with a State Contract Vendor for the acquisition and installation of the infrastructure for Non-Emergency UHF Radio System to service the City of Vineland as part of a Shared Services Agreement by and between the City and Vineland Board of Education through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contracts;

WHEREAS, it has been recommended that contract be awarded to RF Design and Integration, Inc. Bensalem, Pennsylvania based upon the proposal received, in an amount of \$218,135.13 as attached hereto and made a part hereof; and

WHEREAS, the availability of funds for said contract to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

- 1. **THAT** this contract for the acquisition and installation of infrastructure for the Non-Emergency UHF Radio System to service the City of Vineland is awarded to RF Design and Integration Inc., Bensalem, Pennsylvania pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), under the State of New Jersey Cooperative Purchasing Program.
- 2. **THAT** the Purchasing Agent be and the same is hereby authorized to issue a contract to RF Design and Integration Inc., Bensalem, Pennsylvania based upon the proposal received, for the infrastructure acquisition and installation of Non-Emergency UHF Radio System servicing the City of Vineland in an amount of \$218,135.13 in accordance with the proposal attached hereto and made a part hereof.
