

RESOLUTION NO. 2021-269

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) 2022 OR NEWER PETERBILT 567 TANDEM AXLE CAB AND CHASSIS WITH SWAP LOADER MODEL SL 518 HOOK LIFT WITH TWO MONSTER 30YD LEAF MACHINES FROM HUNTER JERSEY PETERBILT, 524 MONMOUTH ROAD, CLARKSBURG, NJ, IN A TOTAL AMOUNT OF \$354,922.84, PURSUANT TO A NATIONAL COOPERATIVE CONTRACT AGREEMENT WITH SOURCEWELL, CONTRACT 060920-PMC.

WHEREAS, the City of Vineland Department of Public Works is in need of one (1) 2022 or Newer Peterbilt 567 Tandem Axle Cab and Chassis with Swap Loader Model SL 518 Hook Lift with Two Monster 30YD Leaf Machines; and

WHEREAS, the City of Vineland is a member of a National Cooperative Purchasing Agreement known as Sourcewell under member number 19409; and, Sourcewell is a national cooperative contract organization; and,

WHEREAS, Sourcewell, National Cooperative Purchasing Program has acted as lead agency and awarded Contract 060920-PMC, Class 5-8 Chassis with Related Equipment. Specific information regarding the contract may be found on the Sourcewell website at www.sourcewell-mn.gov; and,

WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to purchase one (1) 2022 or Newer Peterbilt 567 Tandem Axle Cab and Chassis with Swap Loader Model SL 518 Hook Lift with Two Monster 30YD Leaf Machines using the offered National Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by Hunter Jersey Peterbilt; and

WHEREAS, the City of Vineland intends under Sourcewell, under the Category: Class 5-8 Chassis with Related Equipment, Contract 060920-PMC, to purchase from Hunter Jersey Peterbilt, 524 Monmouth Road, Clarksburg, NJ, one (1) 2022 or Newer Peterbilt 567 Tandem Axle Cab and Chassis with Swap Loader Model SL 518 Hook Lift with Two Monster 30YD Leaf Machines, in a total amount of \$354,922.84, as listed in the Quotation, made available through Sourcewell.

WHEREAS the Director of Public Works and the Qualified Purchasing Agent, with the concurrence of the Business Administrator, recommend the use of the National Cooperative Pricing through Sourcewell for this procurement;

WHEREAS, notice of the within purchase has been published on May 24, 2021, with a 10-day comment period as required by Local Finance Notice 2012-10 and;

WHEREAS, the City of Vineland Purchasing Agent has determined that the use of the offered National Cooperative Contract will result in cost savings after all factors, including charges for service, material and delivery have been considered and has verified that such equipment is not available through State Contract awarded by the Division of Purchase and Property in the New Jersey Department of the Treasury pursuant to N.J.S.A. 40A:11-12; and

WHEREAS, the availability of funds for said purchase to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare a purchase order to procure the one (1) 2022 or Newer Peterbilt 567 Tandem Axle Cab and Chassis with Swap Loader Model SL 518 Hook Lift with Two Monster 30YD Leaf Machines at a cost of \$354,922.84.

BE IT FURTHER RESOLVED that the purchase order shall contain a requirement that “the vendor shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request”.
