A RESOLUTION AWARDED AN OPEN-ENDED CONTRACT TO SIMPLY CLEAN AIR & WATER INC., NEWINGTON, CT FOR THE FURNISHING, DELIVERY AND INSTALLATION OF MOBILE DEMINERALIZER SYSTEM - WEST SUB C.T.

WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing, delivery and installation of Mobile Demineralizer System - West Sub C.T., for a period of one year starting July 1, 2021 and ending June 30, 2022, with option for an second year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on May 11, 2021, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of June 1, 2021 submitted a written report and tabulation of the bids received and has recommended that an open-ended contract for the furnishing, delivery and installation of Mobile Demineralizer System - West Sub C.T., be awarded to Simply Clean Air & Water Inc., Newington, CT, based on unit pricing, with the estimated contract total amount not to exceed \$15,600.00, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-ended contract for the furnishing, delivery and installation of Mobile Demineralizer System - West Sub C.T., for a period of one year starting July 1, 2021 and ending June 30, 2022, with option for an second year, be and the same is awarded to Simply Clean Air & Water Inc., Newington, CT, based on unit pricing, with the estimated contract total amount not to exceed \$15,600.00, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
