RESOLUTION EXERCISING OPTION TO EXTEND
CONTRACT C19-0092 FOR SUPPLY OF NATURAL GAS
FOR THE VINELAND MUNICIPAL ELECTRIC UTILITIES
SIMPLE CYCLE GAS TURBINE.

WHEREAS, on August 27, 2019, City Council adopted Resolution No. 2019-356, awarding a contract to Direct Energy Business Marketing, LLC, Iselin, NJ for Supply of Natural Gas for the Vineland Municipal Electric Utilities Simple Cycle Gas Turbines; and

WHEREAS, the specifications included an option to extend for three (3) additional two (2) year terms; and

WHEREAS, the Purchasing Agent has advised that it is necessary to exercise the first of the three (3) two (2) year option renewal for the period September 1, 2021 through August 31, 2023, in the amount of \$6,500,000.00; and

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized and directed to amend Resolution 2019-356 to allow for the first of the three (3) two (2) year option renewal for Contract No. C19-0092, issued to Direct Energy Business Marketing, LLC, Iselin, NJ for Supply of Natural Gas for the Vineland Municipal Electric Utilities Simple Cycle Gas Turbines, for the period September 1, 2021 through August 31, 2023, in the amount of \$6,500,000.00.
