ORDINANCE NO. 2021-<u>45</u>

AN ORDINANCE PROVIDING FOR NO PARKING RESTRICTIONS ALONG A PORTION OF WASHINGTON AVENUE.

WHEREAS, the City Engineer has recommended that parking be prohibited along a portion of Washington Avenue because of concerns from a business that tractor trailers do not have enough space to backup into their loading docks or turn their trailers around due to parking on both sides of the roadway; and

WHEREAS, currently, parking is permitted on both sides of Washington Avenue which is about 28 feet wide from curb to curb.

WHEREAS, said recommendation has the concurrence of the Vineland Police Department and the City Solicitor and is considered to be in the best interest of the City of Vineland; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF VINELAND THAT:

SECTION 1. No person shall park a vehicle between the hours of 9:00 a.m. to 2:00 p.m. upon any of the following described streets or parts of streets:

Name of Street	Side	Location
Washington Avenue	South	From a point 280 feet west of the easterly curbline of Sixth Street to a point 190 feet east thereof.

SECTION 2. Signs shall be erected and maintained as authorized by the Commissioner of Transportation of the State of New Jersey.

SECTION 3. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This Ordinance shall take effect upon passage and publication as provided by law.


