RESOLUTION AMENDING RESOLUTION 2017-18,
AWARDING A CONTRACT FOR UNIFORM
RENTAL/LAUNDRY SERVICES FOR THE CITY OF
VINELAND ELECTRIC UTILITY.

WHEREAS, on January 10, 2017, the City Council of the City of Vineland, adopted Resolution No. 2017-18, entitled "A RESOLUTION AWARDING AN OPEN-END CONTRACT FOR UNIFORM RENTAL/LAUNDRY SERVICES FOR THE CITY OF VINELAND ELECTRIC UTILITY, TO CLEAN RENTAL SERVICES, INC., PHILADELPHIA, PA"; and

WHEREAS, the City has been notified that Cintas Corporation, Aston, PA has acquired Clean Rental Services, Inc., Philadelphia, Pa; and

WHEREAS, Cintas has agreed to take over the above contract, honoring the same unit pricing; and

WHEREAS, it is in the best interest of the City of Vineland to amend Resolution 2017-18 to cancel contract C17-0009 issued to Clean Rental Services and issue the contract to Cintas Corporation, Aston, PA, at the same cost and services as were initially awarded to Clean Rental Services;

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Vineland that Resolution No. 2017-18 is hereby amended to cancel contract C17-0009 issued to Clean Rental Services and issue the contract to Cintas Corporation, Aston, PA, for Uniform Rental/Laundry Services for the City of Vineland Electric Utility, in the amount not to exceed \$45,227.00, beginning July 13, 2021 through March 26, 2022.
