A RESOLUTION AWARDING AN OPEN-END CONTRACT
TO KOPPERS UTILITY AND INDUSTRIAL PRODUCTS,
LELAND, NC FOR THE FURNISHING OF SOUTHERN PINE
POLES.

WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing of Southern Pine Poles for the Vineland Municipal Electric Utility, for a period of one year from date of award, with option to renew for one (1) additional year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on August 6, 2021, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of August 17, 2021 submitted a written report and tabulation of the bids received and has recommended that an open-end contract for the furnishing of Southern Pine Poles for the Vineland Municipal Electric Utility, be awarded to Koppers Utility and Industrial Products, Leland, NC, in an estimated amount of \$87,678.77, and option year pricing increase of 3%, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for the furnishing of Southern Pine Poles for the Vineland Municipal Electric Utility, for a period of one year from date of award, with option to renew for one (1) additional year, be and the same is awarded to Koppers Utility and Industrial Products, Leland, NC, in an estimated amount of \$87,678.77, and option year pricing increase of 3%, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
