INC.) (\$149,040.00)**

WHEREAS, on August 25, 2020, this Board duly adopted Resolution 2020-428, a Resolution Awarding a Contract for Supplying and Laying Hot Mix Asphalt for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS; Bid # 20-27; and

WHEREAS, the Director of Purchasing has advised that it is necessary to exercise the option to renew the contract for an additional one (1) year term through to August 31, 2022; and

WHEREAS, the maximum contract award amount is \$149,040.00; and

WHEREAS, no amount will be encumbered until such time as goods or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$149,040.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY

COMMISSIONERS OF THE COUNTY OF CUMBERLAND, as follows:

That this Board hereby authorizes an amendment to Resolution 2020-428 exercising the option to renew said contract for an additional one (1) year term through to August 31, 2022 in the maximum amount of \$149,040.00. All other terms and conditions of the original contract shall remain unchanged.
