RESOLUTION AMENDING RESOLUTION 2021-373 TO CORRECT A TYPOGRAPHICAL ERROR RELATING TO A SPECIAL ITEM OF REVENUE FOR INSERTION IN THE CALENDAR YEAR 2021 BUDGET OF THE CITY OF VINELAND MADE AVAILABLE FROM A NEW JERSEY, DEPARTMENT OF LAW AND PUBLIC SAFETY, FY2020 HAZARDOUS MATERIALS EMERGENCY PREPAREDNESS (HMEP) PLANNING AND TRAINING GRANT.

- Resolution No. 2021-373 is hereby amended to provide for the corrected sum of \$3,990.00 made available from a State of New Jersey, Department of Law and Public Safety, FY2020 Hazardous Materials Emergency Preparedness (HMEP) Planning and Training Grant.

The Director of the Division of Local Government Services is hereby requested to approve the insertion of an item of revenue in the budget of the Calendar Year 2021 in the **corrected sum of \$3,990.00**, which item is now available as a revenue from an increase in State of New Jersey, Department of Law & Public Safety, FY2020 Hazardous Materials Emergency Preparedness (HMEP) Planning and Training Grant, pursuant to the provisions of statute.
- 3. A like sum of \$3,990.00, be and the same is hereby appropriated under the caption of State of New Jersey, Department of Law & Public Safety, FY2020 HMEP Grant
