RESOLUTION NO. 2021- 437

RESOLUTION RATIFYING AND CONFIRMING THE APPOINTMENT OF MAYOR ANTHONY FANUCCI, COUNCILMAN PAUL SPINELLI, FERNANDO TORRES, RAQUEL SOTO AND SUZETTE DEMARCHI AS MEMBERS OF THE BOARD OF DIRECTORS OF THE ENTERPRISE ZONE DEVELOPMENT CORPORATION OF VINELAND AND MILLVILLE.

WHEREAS, the following members of the Enterprise Zone Development Corporation of Vineland and Millville (UEZ) have resigned their positions; Nicholas Fiocchi, Antony Thomas and Humberto Vasquez; and

WHEREAS, by correspondence dated September 3, 2021, Mayor Anthony Fanucci has indicated his intent to continue to serve on the UEZ Board and further has re-appointed Councilman Paul Spinelli to serve as the one member of the Vineland Governing Body to serve on the UEZ Board in accordance with their By-Laws; and

WHEREAS, by said correspondence, Mayor Fanucci has further appointed Raquel Soto to fill the unexpired term of Nicholas Fiocchi as a member of the business community, Suzette DeMarchi to fill the unexpired term of Antony Thomas as a member of a community organization and Fernando Torres to fill the unexpired term of Humberto Vasquez as a member of the business community; and

WHEREAS, after consideration of the Mayor's recommended appointments as well as the qualifications of Raquel Soto, Suzette DeMarchi and Fernando Torres, the Council of the City of Vineland finds that it is in the best interest of the City of Vineland to ratify and confirm the appointments of Mayor Fanucci, Councilman Spinelli, Raquel Soto, Suzette DeMarchi and Fernando Torres Rabbai to the Board of Directors of the Enterprise Zone Development Corporation of Vineland and Millville.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Vineland that the action of the Mayor of the City of Vineland in appointing Mayor Anthony Fanucci, Councilman Paul Spinelli, Raquel Soto to fill the unexpired term of Nicholas Fiocchi as a member of the business community, Suzette DeMarchi to fill the unexpired term of Antony Thomas as a member of a community organization and Fernando Torres to fill the unexpired term of Humberto Vasquez as a member of the business community until replaced or reappointed is hereby ratified and confirmed, said appointment effective immediately.

Dear Council President Arthur and Members of City Council,

As you are probably aware, Governor Murphy refunded the Urban Enterprise Zones within the State of New Jersey. As such, the City of Vineland is entitled to five members on the Board of Directors of the Enterprise Zones Development Corporation of Vineland and Millville. Millville is entitled to four members on the said Board.

In accordance with the bylaws of the Enterprise Zone Development Corporation of Vineland and Millville, the Mayor of each City appoints members to the Board with the advice and consent of City Council.
