BE IT RESOLVED that the City Council of the City of Vineland formally approves the grant application for the above-stated project; and

2. THAT the Mayor and Clerk are hereby authorized to execute the grant agreements on behalf of the City of Vineland and that their signature constitutes acceptance of the terms and conditions of the grant agreements and approves the execution of the grant agreement.
3. THAT the City Engineer is designated as the City's representative responsible for project direction and management of said agreement.


