A RESOLUTION AWARDED A CONTRACT TO SOUTH STATE INC., BRIDGETON, NJ TO COMPLETE GARDEN AND MILL TRAFFIC SIGNALIZATION, IN THE AMOUNT OF \$2,438,778.83.

WHEREAS, the City of Vineland has heretofore advertised for bids to Complete Garden and Mill Traffic Signalization, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on November 9, 2021, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of November 16, 2021 submitted a written report and tabulation of the bids received and has recommended that a contract to Complete Garden and Mill Traffic Signalization, be awarded to South State Inc., Bridgeton, NJ, in the amount of \$2,613,320.67, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract to Complete Garden and Mill Traffic Signalization, be and the same is awarded to South State Inc., Bridgeton, NJ, on their bid in the amount of \$2,613,320.67 said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
