A RESOLUTION AMENDING RESOLUTION NO. 2021-649 AUTHORIZING A CONTRACT TO CINTAS CORP., ASTON, PA, FOR FACILITIES MANAGEMENT PRODUCTS & SOLUTIONS (UNIFORM RENTAL & CLEANING).

WHEREAS, December 28, 2021, the City Council of the City of Vineland, adopted Resolution No. 2021-649, entitled "A RESOLUTION AUTHORIZING A CONTRACT TO CINTAS CORP., ASTON, PA FOR FACILITIES MANAGEMENT PRODUCTS & SOLUTIONS (UNIFORM RENTAL & CLEANING), IN THE AMOUNT NOT TO EXCEED \$55,000.00, PURSUANT TO A NATIONAL COOPERATIVE CONTRACT WITH PRINCE WILLIAM COUNTY PUBLIC SCHOOLS"; and

WHEREAS, said Resolution awarded the above contract in an amount not to exceed \$55,000.00, for three (3) years with option to renew for an additional two (2) year term; and

WHEREAS, the Purchasing Agent has requested the Resolution No. 2021-649 be amended to provide for the contract cost for each year;

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland:

1. THAT Resolution No. 2021-649 authorizing Facilities Management Products & Solutions (Uniform Rental & Cleaning) is hereby amended to read as follows:

**Amount not to exceed shall be \$165,000.00, (\$55,000 x 3 years = \$165,000.00)**

2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same on behalf of the City.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
