

RESOLUTION NO. 2022- 48

A RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES AGREEMENT WITH FRALINGER ENGINEERING, BRIDGETON, NJ, FOR 2022 MUNICIPAL SURVEYING SERVICES.

WHEREAS, the City of Vineland requested proposals and received two (2) responses for 2022 Municipal Surveying Services; and

WHEREAS, the City Engineer has recommended that a contract for the required services be awarded to Fralinger Engineering, Bridgeton, NJ, based upon the proposal received, pursuant to a fair and open process; and

WHEREAS this contract is awarded in an amount not to exceed \$150,000.00 for a contract period of one year from date of award; and

WHEREAS, the availability of funds for said Professional Services Contract to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the Local Public Contract Law (N.J.S.A. 40A:11-1, et seq) requires that the Resolution authorizing the award of contract for Professional Services without competitive bidding and the contract itself must be available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that said contract for Professional Services for 2022 Municipal Surveying Services be awarded to Fralinger Engineering, Bridgeton, NJ, based upon the proposal received, pursuant to a fair and open process, in the amount not to exceed \$150,000.00.

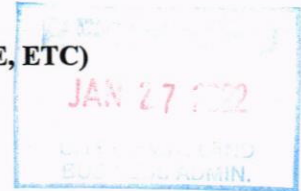
