A RESOLUTION RATIFYING AND CONFIRMING THE  
APPOINTMENT OF POLICE CHAPLAINS.

WHEREAS, the City of Vineland created the position of Police Chaplain by Ordinance No. 2013-34, as amended, Chapter 123, Article VIII, in the Code of the City of Vineland, in accordance with N.J.S.A. 40A:14-141; and

WHEREAS, the position of Police Chaplain is a volunteer position, serving the department under the Director of Public Safety and subject to the control of the Chief of Police; and

WHEREAS, all Police Chaplains shall be ordained clergy in good standing in the religious body from which he/she is selected. The Chaplain shall have basic training and shall be a certified Police Chaplain credentialled in accordance with the rules and regulations of the City of Vineland Police Department, and serve in that capacity without rank or salary; and

WHEREAS, a person appointed as Chaplain shall serve during the term of the Mayor and shall serve until he/she is either replaced or reappointed; and

WHEREAS, the Mayor shall appoint Police Chaplains in accordance with City of Vineland Code Chapter 123, Article VIII, with the advice and consent of City Council.

NOW THEREFORE BE IT RESOLVED, the following Police Chaplains are hereby appointed, at the recommendation of the Chief of Police, the Director of Public Safety and the Mayor, to serve during the term of Mayor Anthony R. Fanucci:

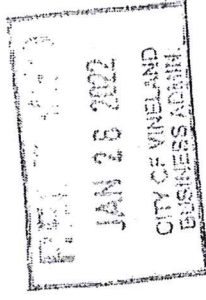
