A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO COLLIERS ENGINEERING & DESIGN INC., d/b/a MASER CONSULTING, RED BANK, NJ FOR PROVIDING TESTING SERVICES (SUPERPAVE HOT MIX ASPHALT, CONCRETE, SOIL TESTING, ETC.) THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM, IDENTIFIER #181-CCCCPS; BID 21-32.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System Identifier #181-CCCCPS, Bid 21-32 for Providing Testing Services (Superpave Hot Mix Asphalt, Concrete, Soil Testing, etc.); and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest responsive, responsible bidder, Collier Engineering & Design Inc., d/b/a Maser Consulting, Red Bank, NJ, for the contract period November 1, 2021 through October 31, 2022, with option to renew for two (2) additional one-year terms, as conditioned in N.J.S.A. 40A11-15 and upon mutual agreement of the parties; and

WHEREAS, the City of Vineland desires to enter into an open end contract with Collier Engineering & Design Inc., d/b/a Maser Consulting, Red Bank, NJ, for Providing Testing Services (Superpave Hot Mix, Asphalt, Concrete, Soil Testing, etc.) under the cooperative pricing system contract awarded by the County of Cumberland for the contract period November 1, 2021 through October 31, 2022, with option to renew for two (2) additional one-year terms; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the contract to be awarded herein;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

RESOLUTION AWARDING CONTRACT FOR PROVIDING TESTING SERVICES (SUPERPAVE HOT MIX ASPHALT, CONCRETE, SOIL TESTING, ETC.) FOR THE CUMBERLAND COUNTY ENGINEERS OFFICE AND THE CUMBERLAND COUNTY COOPERATIVE CONTRACT PURCHASING SYSTEM IDENTIFIER # 181-CCCCPSR]; BID # 21-32 (COLLIERS ENGINEERING & DESIGN, INC. DBA MASER CONSULTING (\$136,885.00)

WHEREAS, this Board duly received and opened bids for providing testing services (Superpave Hot Mix Asphalt, Concrete, Soil Testing, etc.) for the Cumberland County Engineers Office and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; Bid #21-32; and

WHEREAS, the sole bid received is as follows:

WHEREAS, the Director of Purchasing has reported that Colliers Engineering & Design, Inc. dba Maser Consulting, 331 Newman Springs Road, Suite 203, Red Bank, NJ 07701 was the lowest responsive, responsible bidder; and

WHEREAS, the maximum contract award amount is \$136,885.00; and

WHEREAS, no amount will be encumbered until such time as good or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to

provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$136,885.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends a contract be awarded to Colliers Engineering & Design, Inc. dba Maser Consulting in accordance with the specifications and the bid of the contractor in the maximum amount of \$136,885.00 for the contract period November 1, 2021, through October 31, 2022. The County has the sole option to renew this contract for two (2) additional one (1) year terms as conditioned in N.J.S.A. 40A:11-15 and upon mutual agreement of the parties.

2. That, additionally, Colliers Engineering & Design, Inc. dba Maser Consulting shall be declared the winning bidder for the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS.

3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.
