

ORDINANCE NO. 2022- 27

ORDINANCE APPROPRIATING \$30,000 FROM THE SOLID WASTE UTILITY'S CAPITAL IMPROVEMENT FUND FOR THE ACQUISITION OF TRASH TOTES FOR THE SOLID WASTE UTILITY IN AND BY THE CITY OF VINELAND, IN THE COUNTY OF CUMBERLAND, NEW JERSEY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VINELAND, IN THE COUNTY OF CUMBERLAND, NEW JERSEY AS FOLLOWS:

Section 1. \$30,000 is hereby appropriated from the Solid Waste Utility's Capital Improvement Fund for the acquisition of trash totes for the Solid Waste Utility, including all work and materials necessary therefor and incidental thereto.

Section 2. The City hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law.
