

RESOLUTION NO. 2022-202

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) KUBOTA RTV-X1100CW-H FROM CUMMINS EQUIPMENT CO., INC., 717 WHITE HORSE PIKE, HAMMONTON, NJ, IN A TOTAL AMOUNT OF \$21,311.49, PURSUANT TO A NATIONAL COOPERATIVE CONTRACT AGREEMENT WITH SOURCEWELL, CONTRACT 122220-KBA.

WHEREAS, the City of Vineland Recreation Department is in need of one (1) Kubota RTV-X1100CW-H; and

WHEREAS, the City of Vineland is a member of a National Cooperative Purchasing Agreement known as Sourcewell under member number 19409; and, Sourcewell is a national cooperative contract organization; and,

WHEREAS, Sourcewell, National Cooperative Purchasing Program has acted as lead agency and awarded Contract 122220-KBA, Utility Vehicles and Off-Road Vehicles. Specific information regarding the contract may be found on the Sourcewell website at www.sourcewell-mn.gov; and,

WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to purchase one (1) Kubota RTV-X1100CW-H using the offered National Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by Cummins Equipment Co., Inc.; and

WHEREAS, the City of Vineland intends under Sourcewell, under the Category: Utility Vehicles and Off-Road Vehicles, Contract 122220-KBA, to purchase from Cummins Equipment Co., Inc., 717 White Horse Pike, Hammonton, NJ, one (1) Kubota RTV-X1100CW-H, as listed in the Quotation dated May 6, 2022, made available through Sourcewell.

WHEREAS the Department Supervisor and the Qualified Purchasing Agent, with the concurrence of the Business Administrator, recommend the use of the National Cooperative Pricing through Sourcewell for this procurement;

WHEREAS, the City of Vineland Purchasing Agent has determined that the use of the offered National Cooperative Contract will result in cost savings after all factors, including charges for service, material and delivery have been considered and has verified that such equipment is not available through State Contract awarded by the Division of Purchase and Property in the New Jersey Department of the Treasury pursuant to N.J.S.A. 40A:11-12; and

WHEREAS, the availability of funds for said purchase to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare a purchase order to procure the one (1) Kubota RTV-X1100CW-H at a cost of \$21,311.49.

BE IT FURTHER RESOLVED that the purchase order shall contain a requirement that “the vendor shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request”.
