RESOLUTION EXERCISING OPTION TO RENEW
CONTRACT C21-0084 FOR THE SUPPLY OF CEMS
CALIBRATION GAS.

WHEREAS, on June 22, 2021, City Council adopted Resolution No. 2021-294, awarding a contract to Praxair Distribution Inc., Allentown, PA for the supply of CEMS Calibration Gas; and

WHEREAS, the specifications included an option to renew for one additional year; and

WHEREAS, the City of Vineland Municipal Electric Utility – Generation Division and Praxair Distribution, Inc., which is now Linde Gas and Equipment, Inc., have agreed to extend the contract for the option year for the period July 1, 2022 through June 30, 2023 in an amount not to exceed \$58,360.80, at the same terms and conditions of the original contract; and

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that Resolution No. 2021-294 is hereby amended to allow the Purchasing Agent to issue an extension to Contract No. 21-0084, to Praxair Distribution Inc., which is now Linde Gas and Equipment Inc., Allentown, PA for the supply of CEMS Calibration Gas, for the option year beginning July 1, 2022 through June 30, 2023, in an amount not to exceed \$58,360.80, at the same terms and conditions of the original contract.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.

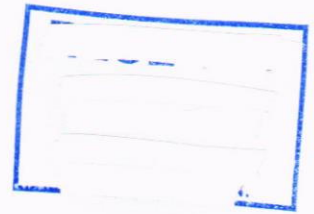
