RESOLUTION EXERCISING OPTION TO RENEW
CONTRACT C21-0088 FOR PRESSURE PIPING,
FABRICATION AND INSTALL PROJECTS.

WHEREAS, on July 13, 2021, City Council adopted Resolution No. 2021-314, awarding a contract to Monarch Boiler Const. Co., Inc., Blackwood, NJ for Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility – Generation Division, for the period of one year beginning August 1, 2021 and continuing until July 31, 2022; and

WHEREAS, the specifications included an option to renew for one additional year; and

WHEREAS, the Municipal Electric Utility and Monarch Boiler Const. Co. have agreed to extend the contract for the option year through July 31, 2023 in the amount of \$192,620.00, at the same terms and conditions of the original contract; and

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that Resolution No. 2021-314 is hereby amended to allow the Purchasing Agent to issue an extension to Contract No. 21-0088, to Monarch Boiler Const. Co., Inc., Blackwood, NJ Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility – Generation Division, for the option year through July 31, 2023 in the amount of \$192,620.00, at the same terms and conditions of the original contract.
