A RESOLUTION TO AMEND RESOLUTION NO. 2022-333 ADOPTED 8/9/22 ENTITLED A RESOLUTION AUTHORIZING THE CANCELLATION OF TAXES FOR **CY 2022** FOR THE REASON RECOMMENDED BY THE CITY OF VINELAND TAX COLLECTOR.
