

RESOLUTION NO. 2022-449

A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO RICHARD E. PIERSON MATERIALS, CORP., BRIDGEPORT, NJ FOR SUPPLYING AND DELIVERING VOC-COMPLIANT HIGH PERFORMANCE COLD PATCH THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM, IDENTIFIER #181-CCCCPS BID #22-31.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Delivering VOC-Compliant High Performance Cold Patch; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest, responsive, responsible bidder, Richard E. Pierson Materials, Corp., Bridgeport, NJ, for the contract period September 1, 2022 through August 31, 2023, with option to renew for one (1) additional year, based on the quoted price as follows:

Pierson Materials, Corp., for Supplying and Delivering VOC-Compliant High Performance Cold Patch for the contract period September 1, 2022 through August 31, 2023, with option to renew for one (1) additional year, based upon the open-ended contract awarded by the County of Cumberland cooperative pricing system.
2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to Richard E. Pierson Materials, Corp., for Supplying and Delivering VOC- Compliant High Performance Cold Patch, as stated above.
