The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Paul F. Spinelli.

The Municipal Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 28, 2016 by the City Clerk in the following manner:

The Clerk reviewed the changes to the agenda since the April 18 work session. Ordinance No. 2017-34, to exceed the municipal budget appropriation limits and to establish a CAP bank, was added for introduction. Resolution No. 2017-192, authorizing the subordination of mortgage liens held by the City of Vineland with respect to 400 South Third Street, Vineland, New Jersey, was revised to add language to the body of the resolution. Resolution No. 2017-196, commending Fabian Villanueva, Michael Villanueva and Christopher Diaz for their honesty, was added. A communication from Mayor Fanucci regarding the appointment of Robert E. Dickenson, Jr. to the position of Director of the Department of Administration, designated as Business Administrator, was added. Resolution No. 2017-197, ratifying and confirming the appointment of Robert E. Dickenson, Jr. as Director of the Department of Administration designated as Business Administrator, was added. Resolution No. 2017-198, to introduce the calendar year 2017 budget of the City of Vineland, was added. Resolution No. 2017-199, authorizing the execution of a shared services agreement with the Cumberland County Improvement Authority for construction inspection services for a new well in the City of Vineland, was added.

Councilwoman Calakos reminded other members about the reception this Thursday at the Vineland Historical & Antiquarian Society.

Assistant Business Administrator Dickenson thanked Finance Officer Susan Baldosaro for the budget preparation work.

President Spinelli entertained a motion by Councilwoman Calakos, and seconded by Councilman Vargas, to adjourn the meeting.
