The Regular Meeting of the City Council of the City of Vineland was called to order by the President, Paul F. Spinelli.

The Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 12, 2018 by the City Clerk, in the following manner:

1. Posting written notice on the official bulletin board in the lobby of the City Hall;
2. Providing written notice to the offices of The Daily Journal and The Press of Atlantic City; and;
3. Filing written notice in the office of the City Clerk of the City of Vineland.

The Clerk read a public notice from NJDEP regarding a public meeting and comment period concerning North East Avenue & East Forest Grove Road Ground Water Contamination Site, to be conducted in City Hall on Thursday, September 26 at 6:30 p.m.

The President asked if there was anyone in the audience who wished to be heard at this time.

Sean Thom, Millville. He requested that the city terminate its contract with the U.S. Immigration and Customs Enforcement (ICE). He claimed there was no mention of ICE in the title of the resolution approving the contract, nor in the minutes of the meeting. He related other opinions about ICE.

Justina Lopez, Vineland. She claimed asylum seekers are being denied refuge by ICE. She also claimed the contract between the City and ICE is illegal.

Dan Cueva, Vineland. He said our State is a state of immigrants. He claimed undocumented workers also contribute to our economy.

Brianne Davis. She read a prepared statement and urged the termination of the contract with ICE.

Claudia Estevez. She stated that to some students there is a real threat, even through a federal law enforcement agency.

Roger Merle, Malaga. He spoke about the history of immigration in South Jersey. He also acknowledged that the contract was passed prior to Governor Murphy's inauguration.

Ervin Moreno, Atlantic City. He claimed the contract was done in secret.

Ellen Tofield, Camden County. She said she was present in solidarity with the other protestors.

Associate Solicitor Michael Benson stated the contract in question has been reviewed by the Cumberland County Prosecutor, Jennifer Webb McRae. He read the Prosecutor's letter, stating that the contract was proper.

President Spinelli related some of his experiences as a teacher in Atlantic City. He said the matter will be discussed.
