There being no one to be heard, the Clerk reviewed changes to the agenda since the February 18 work session. Ordinance 2020-09, to exceed the municipal budget appropriation limits and to establish a CAP bank, was added. A revised version of Resolution 2020-100, authorizing a contract award to a State contract vendor, Dell, Round Rock, TX, for the annual hardware/software support renewal related to compellent storage center systems, in an amount not to exceed \$29,358.68, was provided, to revise the contract period. A revised version of Resolution 2020-101, awarding a contract to Rumsey Electric Co., Conshohocken, PA, for the furnishing and delivery of aluminum line wire and cable for the Vineland Municipal Electric Utility-Distribution Division, was provided, to revise the evaluation form. Resolution 2020-115, authorizing the execution of a shared service agreement by and between the City of Vineland and Cumberland County Board of Health for hazardous material emergency response, was added. Resolution 2020-116, authorizing a contract award to a State contract vendor, Winner Ford, Cherry Hill, NJ, for the purchase of four (4) 2020 Ford Fusions for Licenses and Inspections, Code Enforcement Division, was added. Resolution 2020-117, authorizing a contract award to a State contract vendor, Winner Ford, Cherry Hill, NJ, for the purchase of five (5) 2020 Ford Fusions for the Department of Health, was added. A communication from Mayor Fanucci appointing Josephine Orlando-Spinelli to the Police Athletic League Board of Directors commencing February 26, 2020 and expiring February 22, 2021, was added.
