Councilman Franceschini commented he is against bringing recreational cannabis into the City due to the adverse health and social conditions effects on our adults and children. Cumberland is one of the poorest counties in the State, why should we be compelled to legalize a substance that can harm our children. In his view, call municipalities in Cumberland County should ban cannabis because of its poor health statistics.

Councilman Spinelli commented he agreed with his colleague Councilman Franceschini on the premise and said if he were to vote personally on the matter, it may be different than how he votes tonight as a representative for the City. Councilman Spinelli said cannabis is here and the City is going to try to control it by regulation and laws. Frankly, while he agreed with the health issues in Cumberland County, whether or not the City passes the ordinance, he believed it will have little to no effect. Since close to 70% of Vineland's population have voted to approve Marijuana, and he is a representative of that body, he must vote to reflect such.

Councilman Acosta commented he shared the sentiment of both his fellow colleagues and must say, that the work that has been put forth to tackle this subject has been a significant improvement. He stated the City must regulate this substance appropriately. He also commended the staff who have drafted a well-crafted ordinance that has some "teeth" into it. He is looking forward to further regulation dealing with enforcement of Cannabis and hopes to have some really sound conversation concerning the matter. He finished by stating he will vote "yes" as a result of all the changes in the ordinance that have taken place since its original draft.

Councilman Vargas, mentioned that morally he is against it however in given thought about the issue, his vote is not about his personal feelings on the matter, but a decision that was made by the New Jersey voters.
